5 167], the *Certificate of Service Regarding Negative Notice of Trustee's Intent to Abandon*
6 *Property Pursuant to 11 U.S.C. § 554* [ECF No. 168], the *Declaration of Victoria L. Nelson In*
7 *Support of Notice of No Opposition to Negative Notice of Trustee's Intent to Abandon Property*
8 *Pursuant to 11 U.S.C. § 554* [ECF No. 198], the exhibits attached thereto, and all other pleadings

10 The Notice sought authority to abandon following personal property located at 2720
11 Council Tree Ave, Suite 242, Fort Collins, Colorado 80528 pursuant to 11 U.S.C. § 554: (a)
12 general office furniture, miscellaneous office supplies, and various used kitchen supplies and (b)
13 general office equipment and electronics (collectively, the "Property").

14 It appearing to the Court that the relief requested in the Notice is necessary and in the best
15 interests of the Bankruptcy Estate and its creditors, that the Property is burdensome to the
16 Debtor's bankruptcy estate or is of inconsequential value and benefit to the bankruptcy estate, and
17 upon consideration of the pleadings and good cause appearing,

18 **IT IS HEREBY ORDERED** that:

- 19 (1) The relief requested in the Notice is GRANTED in its entirety;
- 20 (2) The Property identified in the Notice is abandoned from the Debtor's bankruptcy
21 estate pursuant to 11 U.S.C. § 554; and
- 22 (3) Nothing in this Order shall constitute the abandonment of any real or personal
23 property, or subsequently discovered assets that may comprise the Debtor's bankruptcy estate,
24 that was not specifically identified in the Notice.
