2 *Forensic Accountant, Nunc Pro Tunc to March 17, 2017, for Victoria L. Nelson, Chapter 7*
3 *Trustee Pursuant to 11 U.S.C. §§ 327(a) and 328(a) and Federal Rule of Bankruptcy Procedure*
4 *2014* [ECF No. 213]¹ (the “Application”), filed by VICTORIA L. NELSON, the Chapter 7
5 Trustee in the above-captioned bankruptcy case (the “Trustee”), by and through her counsel of
6 record, Jacob L. Houmand, Esq. and Kyle J. Ortiz, Esq. of the Law Firm of Nelson & Houmand,
7 P.C.² The Application sought authority to employ EisnerAmper LLP as forensic accountant
8 pursuant to 11 U.S.C. §§ 327(a) and 328(a) and Federal Rule of Bankruptcy Procedure 2014.

1 Based upon this review and the findings of fact and conclusions of law placed on the
2 record at the hearing, and incorporated herein pursuant to Federal Rule of Civil Procedure 52,
3 made applicable to this matter pursuant to Federal Rules of Bankruptcy Procedure 9014(c) and
4 7052, and good cause appearing,

5 **IT IS HEREBY ORDERED** that:

6 (1) The Application is GRANTED in its entirety; and

7 (2) The Trustee appointed in the above-referenced bankruptcy case is hereby
8 authorized pursuant to 11 U.S.C. §§ 327(a) and 328(a) and the Federal Rule of Bankruptcy
9 Procedure 2014 to employ EisnerAmper LLP as forensic account effective as of March 17, 2017;
10 and

11 (3) The terms of such employment shall be as described in the Application and in the
12 supporting Verified Statement of Hubert Klein, CPA and

13 (4) Such terms of employment are approved as reasonable in accordance with 11
14 U.S.C. §§ 328 and 330; and

15 (5) Any compensation and reimbursement of expenses are to be awarded by Court
16 order and are to be paid as an administrative expense after notice and a hearing, in accordance
17 with 11 U.S.C. §§ 330 and 503, or surcharged against secured property in accordance with 11
18 U.S.C. § 506(c), if appropriate.
