IT IS HEREBY ORDERED that:

(1) The Stipulation is APPROVED in its entirety;

(2) Proof of Claim 235 shall be allowed as follows: (i) an allowed priority claim under 11 U.S.C. § 507(a)(4) in the amount of \$2,420.00; and (ii) an allowed general unsecured claim in the amount of \$1,330.00.

(3) Proof of Claim 236 shall be allowed and entitled to priority under 11 U.S.C. § 507(a)(4); and

(4) Proof of Claim 237 shall not be entitled to any priority under 11 U.S.C. § 507(a)(4) and shall be allowed as a general unsecured claim in the amount of \$4,350.00
