1 to Exceed One Thousand Dollars (\$1,000) (the “Application”) filed by Victoria L. Nelson, the  
2 Chapter 7 Trustee in the above-captioned bankruptcy case by and through her proposed counsel  
3 of record, Jacob L. Houmand, Esq. of the law firm Nelson & Houmand, P.C. The Application

17 Destruction, Inc. An Amount Not to Exceed One Thousand Dollars (\$1,000) is **GRANTED** in its  
18 entirety.
