Victoria L. Nelson, the appointed Chapter 7 Trustee in the above-captioned bankruptcy case (the "Trustee"), by and through her proposed attorney of record Jacob L. Houmand, Esq. of the law firm of Nelson & Houmand, P.C., hereby files this Omnibus Motion of the Chapter 7 Trustee for Entry of Order Authorizing the Rejection of Executory Contracts [Property Management Agreements] Pursuant to 11 U.S.C. § 365(a) (the "Motion").¹

 3 Entry of Order Authorizing the Rejection of Executory Contracts Pursuant to 11 U.S.C. § 365(a)

MEMORANDUM OF POINTS AND AUTHORITIES**I. INTRODUCTION**

Ameri-Dream Realty, LLC (the “Debtor”) is a real estate brokerage firm that represented clients in the purchase and sale of real property throughout Las Vegas, Nevada. The Debtor also had a property management division that managed several thousand real properties located throughout the valley in Las Vegas, Nevada. As part of its property management division, the Debtor has executed real property management agreements (collectively, the “Property Management Agreements”) with landowners whereby the Debtor agreed to perform the following services: (a) the monthly collection of rents from tenants, (b) payment of Homeowner Association (“HOA”) fees, (c) the general repair and maintenance of the properties at issue, and (d) the segregation of security deposits (the “Security Deposits”) pursuant to Nevada Revised Statute (“N.R.S.”) Chapter 645. Despite the fact that the Debtor was required to maintain the Security Deposits in a segregated trust account for the benefit of the various landowners and tenants, the Trustee is informed and believes that the spouse of the Debtor’s principal embezzled approximately One Million One Hundred Thousand Dollars (\$1,100,000) of the Security Deposits. As a result, there is currently an insufficient balance in the Security Deposit trust account to cover the full amount of the Security Deposits that are required to be segregated pursuant to the Property Management Agreements.

This deficiency has made it necessary for the Trustee to reject the Property Management Agreements, which are executory contracts, pursuant to Section 365. The rejection of the Property Management Agreements will allow all of the affected landowners to obtain new property managers for the various real properties at issue. For these reasons, the Trustee respectfully requests that the Court enter an order authorizing the rejection of the Property Management Agreements that are identified in **Exhibit “1”** that is attached hereto.

II. JURISDICTION AND VENUE

The Court has jurisdiction over the bankruptcy case and the subject matter of this Objection pursuant to 28 U.S.C. §§ 157 and 1334. The Objection is a core proceeding under 28 U.S.C. § 157(b)(2). Pursuant to Local Rule 9014.2, if the Court determines that absent consent of

1 the parties the Court cannot enter final orders or judgment regarding the Objection consistent with
 2 Article III of the United States Constitution, the Trustee consents to entry of final orders and
 3 judgment by this Court. Venue before this Court is appropriate under 28 U.S.C. §§ 1408 and
 4 1409.

5 The statutory predicates for the relief requested in the Objection herein are Section 365,
 6 FRBP 6006, and Local Rule 6006.

7 **III. STATEMENT OF FACTS**

8 1. On January 9, 2015, the Debtor filed a voluntary bankruptcy pursuant to Chapter 7
 9 of Title 11 of the United States Code [ECF No. 1].³ See Nelson Declaration.

10 2. On January 9, 2015, Victoria L. Nelson was appointed as the Chapter 7 Trustee in
 11 the Debtor's bankruptcy case [ECF No. 4]. See Nelson Declaration.

12 3. The Debtor is a real estate brokerage firm that represented clients in the purchase
 13 and sale of real property throughout Las Vegas, Nevada. See Nelson Declaration.

14 4. The Debtor also had a property management division that managed thousands of
 15 rental properties for various landowners and tenants throughout Las Vegas, Nevada. As part of its
 16 property management division, the Debtor has executed the Property Management Agreements
 17 with landowners whereby the Debtor agreed to perform the following services: (a) the monthly
 18 collection of rents from tenants, (b) payment of Homeowner Association ("HOA") fees, (c) the
 19 general repair and maintenance of the properties at issue, and (d) the segregation of security
 20 deposits (the "Security Deposits") pursuant to Nevada Revised Statute ("N.R.S.") Chapter 645.
 21 See Nelson Declaration.

22 5. At the time of the Debtor's bankruptcy filing it was a party to several hundred
 23 property management agreements. See Nelson Declaration.

24 6. After the filing of the Debtor's bankruptcy case, the Trustee was informed that the
 25 spouse of the Debtor's principal improperly transferred approximately One Million One Hundred
 26

1 Thousand Dollars (\$1,100,000) from the Security Deposits to the Philippines. These actions have
 2 resulted in a significant deficiency in the amount of Security Deposits that the Debtor was
 3 required to hold in trust pursuant to the Property Management Agreements and N.R.S. Chapter
 4 645. *See* Nelson Declaration.

5 7. As a result of the alleged embezzlement and significant deficiency of the Security
 6 Deposits, the Property Management Agreements cannot be sold, assigned, or otherwise
 7 transferred to third parties by the Trustee in good faith. *See* Nelson Declaration.

8 8. Under the terms of the Property Management Agreements and in accordance with
 9 Nevada State Law, the services must be performed by a licensed property manager working under
 10 a broker authorized by the Department of Business and Industry, Real Estate Division, further
 11 preventing the Trustee from assuming the Property Management Agreements. *See* Nelson
 12 Declaration.

13 9. On January 23, 2015, the Debtor filed its Schedules of Assets and Statement of
 14 Liabilities [ECF No. 10]. The Debtor's Schedule G identifies the significant number of Property
 15 Management Agreements that constitute executory contracts under Section 365. *See* Nelson
 16 Declaration.

17 10. A true and correct copy of one of the Property Management Agreements is
 18 attached to the Nelson Declaration as **Exhibit "1"**. All of the Property Management Agreements
 19 are executed on identical real estate forms. *See* Nelson Declaration.

20 11. The Trustee has spoken with counsel for the Debtor and counsel for the majority of
 21 the Non-Debtor parties to the Property Management Agreements, and all are in agreement that
 22 rejection of the Property Management Agreements is in the best interest of the Estate. *See* Nelson
 23 Declaration.

24 12. On February 2, 2015, the Trustee filed an Ex Parte Motion for Leave to Reject
 25 More than One Hundred (100) Executory Contracts In A Single Motion Pursuant to Federal Rule
 26 of Bankruptcy Procedure 6006(f) (the "Ex Parte Motion") [ECF No. 21]. The Ex Parte Motion
 27 sought leave to reject more than one hundred of the Property Management Agreements as part of
 28 a single motion. *See* Nelson Declaration.

13. On February 3, 2015, the Court entered an Order Granting the Ex Parte Motion for Leave to Reject More than One Hundred (100) Executory Contracts in a Single Motion Pursuant to Federal Rule of Bankruptcy Procedure 6006(f) [ECF No. 24]. *See* Nelson Declaration.

14. A complete list of the Property Management Agreements that the Trustee seeks to reject pursuant to this Motion are identified in **Exhibit "1"** to this Motion.

15. Pursuant to FRBP 6006(1) all parties receiving this Motion should review the Property Management Agreements identified in **Exhibit "1"** to determine if their Property Management Agreement would be rejected pursuant to this Motion.

16. Pursuant to FRBP 6006(f)(2), the Property Management Agreements identified in **Exhibit "1"** attached to his Motion are organized in alphabetical order according to the property owner's last name.

IV. LEGAL ARGUMENT

Section 365(a) provides a Chapter 7 Trustee with the authority to assume or reject executory contracts:

Except as provided in Sections 765 and 766 of this title and in subsections (b), (c), and (d) of this section, the trustee, subject to the court's approval may assume or reject any executory contract or unexpired lease of the debtor.

11 U.S.C. § 365(a).

A Trustee is permitted to "join requests for authority to reject multiple executory contracts or unexpired leases in one motion." FED. R. BANKR. P. 6006(e). The finality of an order granting an omnibus motion to reject executory contracts "shall be determined as though such contract or lease had been the subject of a separate motion." FED. R. BANKR. P. 6006(g).

The Court should enter an order granting the Motion and rejecting the Property Management Contracts pursuant to Section 365(a) because (a) the Property Management Contracts are executory contracts, and (b) the Trustee has properly exercised her business judgment in determining that it is appropriate to reject the Property Management Agreements.

1. The Property Management Contracts Are Executory Contracts within the Provisions of Section 365(a)

It is well-established that the provisions of Section 365(a) only apply to executory contracts that existed on the date of the bankruptcy filing. *See generally*, 11 U.S.C. § 365. An executory contract has been defined as one “on which performance is due to some extent on both sides.” *National Labor Relations Bd. v. Bildisco*, 465 U.S. 513, 521-523 (1984). Whether a contract is “executory” within the meaning of the Bankruptcy Code is determined under federal law. *In re Sentle Trucking Corp.*, 93 B.R. 551, 555 (Bankr. N.D. OH 1988). Whether a particular contract is executory is determined as of the petition date. *In re Penn Traffic Co.*, 524 F.3d 373, 381 (2d Cir. 2008). A non-debtor cannot prevent exercise of a debtor’s Section 365 rights regarding an executory contract through post-petition performance of its obligations under the contract. *Id.* at 382.

Here, the Property Management Agreements are executory in nature because they encompass reciprocal continuing future obligations. Namely, the Debtor would receive a fee for collecting monthly rent, paying HOA fees, and performing any necessary maintenance on the real properties at issue. In exchange, the property owners would receive the services of the Debtor’s property management division. Accordingly, the Property Management Agreements at issue are executory contracts that can be rejected by the Trustee pursuant to Section 365.

2. The Trustee Has Properly Exercised Her Business Judgment in Determining that the Property Management Contracts Should Be Rejected

The decision to reject an executory contract under Section 365(a) is analyzed according to the “business judgment” rule. *In re Chi-Feng Huang*, 23 B.R. 798, 800 (9th Cir. B.A.P. 1982); *In re Tilco*, 558 F.2d 1369, 1372 (10th Cir. 1977); *King v. Baer*, 482 F.2d 552, 557 (10th Cir. 1973); *In re Minges*, 602 F.2d 38, 42-43 (2d Cir. 1979); *In re Hurricane Elkhorn Coal Corp. II*, 15 B.R. 987, 989 (Bankr. W.D.Ky. 1981); *In re Lafayette Radio Electronics Corp.*, 8 B.R. 528, 533 (Bankr. E.D.N.Y. 1981). In determining whether the business judgment standard has been satisfied, courts analyze whether the party whose contract is to be rejected would be damaged

1 disproportionately in relationship to any benefit derived by the general unsecured creditors of the
2 bankruptcy estate. *In re Chi-Feng Huang*, 23 B.R. at 801.

3 Here, the Court should permit the Trustee to reject the executory contracts identified in
4 **Exhibit "1"** hereto because the Trustee has complied with all procedural requirements under
5 FRBP 6006 by clearly identifying the Property Management Agreements as the executory
6 contracts that the Trustee intends to reject via this Motion. The rejection of the Property
7 Management Agreements also satisfies the business judgment standard because the vast majority
8 of the Debtor's creditors are the parties to the Property Management Agreements. If the Property
9 Management Agreements are not rejected by the Trustee, the property owners will have to wait
10 for sixty (60) days from the Petition Date in order to enter into new property management
11 agreements. *See* 11 U.S.C. § 365(d)(1) (providing that all executory contracts and unexpired
12 lease agreements are deemed rejected if they have not been assumed or rejected within sixty (60)
13 days of a bankruptcy filing.). Since the Trustee will not be operating the Debtor's business under
14 Section 721, the property owners either need to collect the monies directly from their tenants or
15 locate new property managers to continue the maintenance of their real properties. The rejection
16 of the Property Management Agreements are further appropriate because of the alleged
17 embezzlement by the spouse of the Debtor's principal. Such an allegation prevents the Trustee
18 from assuming and assigning the Property Management Agreements to third parties given the
19 significant deficiencies in the Security Deposit Trust Accounts. Finally, the Trustee has been
20 informed by counsel for the some of the property owners that they consent to the rejection of the
21 Property Management Agreements. Accordingly, the Property Management Agreements
22 identified in **Exhibit "1"** hereto should be rejected pursuant to Section 365(a).
