16 I, Paul M. Healey, hereby declare as follows:

18 1. I am over the age of 18 and mentally competent. Except where stated on
19 information and belief, I have personal knowledge of the facts in this matter and if called upon to
20 testify, could and would do so. I make this declaration in support of the Trustee's Ex Parte
21 Application for Order Authorizing Employment of Accountant (the "Application").

22 2. I am a certified public accountant licensed in the State of Nevada and am
23 experienced in bankruptcy estate taxation issues.

24 3. It is my belief that I have the requisite experience and expertise to competently
25 perform the duties for the Trustee and have represented panel trustees in other matters within the
26 State of Nevada.

27 4. I have agreed to represent the Trustee and the Debtor's bankruptcy estate as the
28 accountant and to be compensated on an hourly basis with my payment being subject to Court


1 approval. The rates presently charged by my accounting firm are \$185 per hour for my services;
2 \$95 per hour for Christopher Healey; \$85 per hour for Michael Healey; and \$35 per hour for
3 administrative staff, plus costs.

4 5. To the best of my knowledge, information and belief, I have no connection with
5 the Debtor, the creditors of Debtor's bankruptcy estate, or any other party in interest. Further, I
6 represent no interest adverse to the Trustee, the bankruptcy estate, or any other party in interest
7 herein, their respective attorneys and accountants, the United States Trustee, or any person
8 employed in the Office of the United States Trustee.

9 6. I do represent the Trustee in other accounting and taxation transactions unrelated
10 to the Debtors' bankruptcy estate.
