

1 This matter came before this Court on the *Second Interim Application of Nelson &*
 2 *Houmand, P.C. for Allowance of Compensation for Services Rendered During the Period From*
 3 *June 3, 2015, Through November 11, 2015 and For Reimbursement of Expenses Pursuant to 11*
 4 *U.S.C. §§ 330 and 331 and Federal Rule of Bankruptcy Procedure 2016* (the “Application”)
 5 [ECF No. 167]¹, filed on November 11, 2015, by the law firm of Nelson & Houmand, P.C. (the
 6 “Firm”), counsel of record for Victoria L. Nelson, the Chapter 7 Trustee in the above-captioned
 7 bankruptcy case (the “Trustee”). The Application sought interim approval of attorneys’ fees in
 8 the amount of Fifty-Eight Thousand Seven Hundred Ten Dollars (\$58,710.00) and reimbursement
 9 of actual expenses in the amount of One Thousand Nine Hundred Thirty-Seven Dollars and
 10 08/100 (\$1,937.08).

11 No Oppositions were filed to the Application. Jacob L. Houmand, Esq. appeared on
 12 behalf of the Firm and no other appearances were noted on the record.

13 The Court reviewed the Application, the *Declaration of Victoria L. Nelson In Support of*
