

This matter came before this Court on the Ex Parte Application to Employ EisnerAmper LLP As Forensic Accountant, Nunc Pro Tunc for Shelley D. Krohn, Successor Chapter 7 Trustee Pursuant to 11 U.S.C. §§ 327(a) and 328(a) and Federal Rule of Bankruptcy Procedure 2014 (the

"Application") [ECF No. 316]¹, filed by Shelley D. Krohn, the successor chapter 7 trustee in the above-captioned bankruptcy case (the "Trustee"), by and through her general bankruptcy counsel of record, Jacob L. Houmand, Esq. and Kyle J. Ortiz, Esq. of the Houmand Law Firm, Ltd.² The Application sought authority to employ EisnerAmper LLP, *nunc pro tunc*, as forensic accountant pursuant to 11 U.S.C. §§ 327(a) and 328(a) and Federal Rule of Bankruptcy Procedure 2014.

3	(4) Such terms of employment are approved as reasonable in accordance with 11
4	U.S.C. §§ 328 and 330; and
5	(5) Any compensation and reimbursement of expenses are to be awarded by Court
6	order and are to be paid as an administrative expense after notice and a hearing, in accordance
7	with 11 U.S.C. §§ 330 and 503, or surcharged against secured property in accordance with 11
8	U.S.C. § 506(c), if appropriate.
