Bankruptcy Procedure 3007 [ECF No. 277] (the "Objection") filed by Shelley D. Krohn, the Chapter 7 Trustee in the above-captioned bankruptcy case (the "Trustee") by and through her counsel of record, Jacob L. Houmand, Esq. and Kyle J. Ortiz, Esq. of the Houmand Law Firm, Ltd.
