2 This matter came before the Court on the *First Interim Application of EisnerAmper LLP*
3 *for Allowance of Compensation for Services Rendered During the Period From March 17, 2017*
4 *Through March 6, 2019 and For Reimbursement of Expenses Pursuant to 11 U.S.C. §§ 330 and*
5 *331 and Federal Rule of Bankruptcy Procedure 2016* [ECF No. 468]¹ (the “Fee Application”)
6 filed by Shelley D. Krohn (the “Trustee”), the Chapter 7 Trustee in the above-captioned
7 bankruptcy case, by and through her counsel of record, Jacob L. Houmand, Esq. of the Houmand
8 Law Firm, Ltd. The Fee Application sought final approval of professional fees in the amount of
9 \$107,666.50 and reimbursement of actual expenses in the amount of \$289.10 in favor of
10 EisnerAmper LLP (the “Firm”).²

11 No Oppositions were filed to the Fee Application. Jacob L. Houmand, Esq. appeared on
12 behalf of the Firm and no other appearances were noted on the record.
