- On January 9, 2015, Victoria L. Nelson ("Trustee Nelson") was appointed as the 5. Chapter 7 Trustee in the Debtor's bankruptcy case [ECF No. 4].
- 6. On January 28, 2015, the Court entered an Amended Notice of Chapter 7 Bankruptcy Case [ECF No. 12] that established May 14, 2015, as the deadline for creditors to file proofs of claim.
- 7. On February 9, 2015, Trustee Nelson filed an Application for Order Authorizing Employment of the Garden City Group, LLC As Claims and Noticing Agent [ECF No. 88].
- On February 27, 2015, the Court entered an Order Granting Application for Order 8. Authorizing Employment of the Garden City Group, LLC As Claims and Noticing Agent [ECF No. 128].
- 9. Since its employment, Garden City Group ("GCG") has been maintaining the Proofs of Claim that have been submitted by creditors.
