This matter came before the Court on the *Amended Trustees Eighth Omnibus Objection To Proofs Of Claim Pursuant To 11 U.S.C. § 502(B)(1) And Federal Rule Of Bankruptcy Procedure 3007Claim Numbers 5-1, 19-1, 20-1, 24-1, 44-1, 45-1, 61-1, 64-1, 84-1, 109-1, 136-1, 142-1, 201-1, 290-1, 291-1, 293-1, 601-1, 660-1, 836-1, 854-1, 922-1, 923-1, 924-1, and 925-1, Based Lack of Documentation* [ECF No. 381]<sup>1</sup> (the “Objection”) filed by Shelley D. Krohn, the Chapter 7 Trustee in the above-captioned bankruptcy case (the “Trustee”) by and through her counsel of record, Jacob L. Houmand, Esq. and Bradley G. Sims, Esq. of the Houmand Law Firm, Ltd.<sup>2</sup> The Objection sought an order disallowing claims 5-1, 19-1, 20-1, 24-1, 44-1, 45-1, 61-1, 64-1, 84-1, 109-1, 136-1, 142-1, 201-1, 290-1, 291-1, 293-1, 601-1, 660-1, 836-1, 854-1, 922-1, 923-1, 924-1, and 925-1.

No oppositions were filed to the Objection. Bradley G. Sims, Esq. appeared on behalf of the Trustee. No other appearances were noted on the record.
