1 This matter came before the Court on the *Trustee’s Thirteenth Omnibus Objection To*
2 *Proofs Of Claim Pursuant To 11 U.S.C. § 502(B)(1) And Federal Rule Of Bankruptcy Procedure*
3 *3007—Claim Numbers 919-1, 920-1, 927-1, 928-1, and 931-1 – Late Filed Proofs of Claim* [ECF
4 No. 412]¹ (the “Objection”) filed by Shelley D. Krohn, the Chapter 7 Trustee in the above-
5 captioned bankruptcy case (the “Trustee”) by and through her counsel of record, Jacob L.
6 Houmand, Esq. and Bradley G. Sims, Esq. of the Houmand Law Firm, Ltd.² The Objection
7 sought an order finding that claims 919-1, 920-1, 927-1, 928-1, and 931-1 are entitled only to
8 receive a distribution pursuant to 11 U.S.C. § 726(a)(3) because they were untimely filed.

9 No oppositions were filed to the Objection. Bradley G. Sims, Esq. appeared on behalf of
10 the Trustee. No other appearances were noted on the record.

23 record at the hearing, and incorporated herein pursuant to Federal Rule of Civil Procedure 52,

2 7052, and good cause appearing,

3 **IT IS HEREBY ORDERED** that:

- 4 (1) The Objection is SUSTAINED in its entirety; and
- 5 (2) Proofs of claim 919-1, 920-1, 927-1, 928-1, and 931-1 shall be entitled only to
6 receive a distribution pursuant to 11 U.S.C. § 726(a)(3) because they were
7 untimely filed.
