This matter came before the Court on the Trustee's Twelfth Omnibus Objection To Proofs 1 Of Claim Pursuant To 11 U.S.C. § 502(b)(1) and Federal Rule of Bankruptcy Procedure 3007– 2 Claim 100-1, 120-1, 197-1, 299-1, 582-1, 601-1, 667-1,714-1, 926-1, and 932-1 – Duplicate 3 *Claims* [ECF No. 396]¹ (the "Objection") filed by Shelley D. Krohn, the Chapter 7 Trustee in the 4 above-captioned bankruptcy case (the "Trustee") by and through her counsel of record, Jacob L. 5 Houmand, Esq. and Bradley G. Sims, Esq. of the Houmand Law Firm, Ltd.² The Objection 6 sought an order disallowing claims 100-1, 120-1, 197-1, 299-1, 582-1, 601-1, 667-1,714-1, 926-1, 7 and 932-1 as duplicate claims. 8

No oppositions were filed to the Objection. Bradley G. Sims, Esq. appeared on behalf of the Trustee. No other appearances were noted on the record.
