This matter came before the Court on the *Trustee’s Fourteenth Omnibus Objection To Proofs Of Claim Pursuant To 11 U.S.C. § 502(B)(1) And Federal Rule Of Bankruptcy Procedure 3007—Claim Numbers 82-2, 105-1, 108-1, 493-1, 677-1, 678-1, and 856-1 Based On Improper Assertion Of A Priority Claim by an Independent Contractor* [ECF No. 415]<sup>1</sup> (the “Objection”) filed by Shelley D. Krohn, the Chapter 7 Trustee in the above-captioned bankruptcy case (the “Trustee”) by and through her counsel of record, Jacob L. Houmand, Esq. and Bradley G. Sims, Esq. of the Houmand Law Firm, Ltd.<sup>2</sup> The Objection sought an order reclassifying claims 82-2, 105-1, 108-1, 493-1, 677-1, 678-1, and 856-1 as general unsecured claims.

No oppositions were filed to the Objection. Bradley G. Sims, Esq. appeared on behalf of the Trustee. No other appearances were noted on the record.

2 record at the hearing, and incorporated herein pursuant to Federal Rule of Civil Procedure 52,  
3 made applicable to this matter pursuant to Federal Rules of Bankruptcy Procedure 9014(c) and  
4 7052, and good cause appearing,

5 **IT IS HEREBY ORDERED** that:

- 6 (1) The Objection is SUSTAINED in its entirety; and
- 7 (2) Proofs of claim 82-2, 105-1, 108-1, 493-1, 677-1, 678-1, and 856-1 shall all be  
8 reclassified as entirely general unsecured claims.
